

ROCK 'N' RACE Terms and Conditions

1. This competition is being conducted by the **Royal Australian Mint** (ABN 45 852 104 259) Denison Street Deakin ACT 2600. (Promoter)
2. Total value of the prize pool is up to AUD **\$725**
3. The Promoter is offering the opportunity for Australian citizens and permanent residents to enter "**ROCK 'N' RACE Competition**" to go into the running to win one (1) of five (5) prizes.
4. By entering the Competition, the Entrant agrees to abide by these Terms and Conditions. Information regarding prizes and how to enter forms part of these conditions. By entering, the Entrant accepts these Terms and Conditions.

How to Enter

5. Entry to the Competition is open to Australian citizens and permanent residents (Australian Residents) who are aged 18 years and over as at the time of the Competition and who remain Australian Residents for the duration of the promotional period (Entrant(s)).
6. The Promotion commences **12:01am AEDT Thursday 6 May 2021**. Entries close **11:59pm AEDT Wednesday 2 June 2021** (Promotional Period)
7. To enter the competition, an Entrant must purchase at least one (1) of the following products: 2020/2021 20c Coloured Uncirculated Coin – AC/DC, 2021 \$1 Silver Frosted Uncirculated Coin AC/DC or 2020 50c Coloured Uncirculated Coin – 60 Years of Supercars from the Royal Australian Mint.
8. Winners will be identified on **Wednesday 9 June 2021** and notified individually through Facebook on **Friday 11 June 2021**. The specific eligibility requirements for each prize detailed below. Winners will be published on Facebook by **Friday 25 June 2021**.
9. The Promoter is not responsible for any technical malfunctions or problems with internet or network congestion, including injury or damage to an Entrant or any other person's computer related to participation in this promotion and problems with transmission of entries over the internet. The Promoter accepts no responsibility for lost, late or misdirected entries.

Restrictions on Entry

10. The directors, management and employees (and their immediate families, including children and wards, and other persons residing in their household, ex-spouse, de-facto spouse, step parent, grandparent, step grandparent uncle, aunt, niece, nephew, brother, sister, step-brother, step sister or first cousin) of the Promoter, its related entities, distributors, printers, suppliers, providers and agencies associated with the Competition are ineligible to enter the Competition.

 - 2021 \$1 Silver Frosted Uncirculated Coin AC/DC or
 - 2020 50c Coloured Uncirculated Coin – 60 Years of Supercars
 - A winner will be selected by an impartial draw.
 - **A person may only enter the competition ONCE under their name.**
 - Entrants that purchase their 2021 20c Coloured Uncirculated Coin – AC/DC, 2021 \$1 Silver Frosted Uncirculated Coin AC/DC or 2020 50c Coloured Uncirculated Coin – 60 Years of Supercars from a third party other than those listed above will not be eligible to win.
 - Upon request, Entrants must be able to provide proof of purchase from the Royal Australian Mint with the transaction dated between **12:01am AEDT Thursday 6 May 2021** and **11:59pm AEDT Wednesday 2 June 2021** .
 - Upon request, Entrants will need to provide proof of identity and residence.
 - Make contact with the Royal Australian Mint by **Thursday 24 June 2021**.
17. It is the responsibility of the Entrant to ensure that they have met all eligibility requirements.

Adjudication of Prizes

Entries and Intellectual Property

23. Unless expressly stated within these Terms and Conditions, or as otherwise provided by the Promoter all expenses are the responsibility of the Entrants.
24. The Promoter is not liable to any Entrant that does not receive an email, notice or read a Facebook notification, cannot access a webpage or submit their details due to technical difficulties or any other reason.
25. The Promoter is not responsible in any manner whatsoever for any problems or any financial costs incurred, or any combination thereof, including any injury or damage to participants or any other persons related to or resulting from participation in this Competition.
26. The Promoter will not be liable for any loss or damage suffered (including but not limited to direct or consequential loss) or for any personal injury suffered or sustained as a result of receiving, taking or using any prizes, except for any liability which cannot be excluded by law. 30. Subject to the relevant authority approval, if required, the Promoter reserves the right to vary the Prize with a prize of equal or greater value.
31. Subject to the relevant authority approval, if required, the Promoter reserves the right, in its absolute discretion, at any time before the awarding of the prizes to cancel the Competition or to vary or cancel the award of a prize including, without limitation, circumstances where in the Promoter's opinion (which it shall form in its absolute discretion):
 - a. a winner does not satisfy the Competition entry requirements; or
