

**ROYAL AUSTRALIAN MINT DEALER WEBSITE  
(‘MINT DEALER WEBSITE’)  
TERMS AND CONDITIONS OF USE**

***Access to the Mint Dealer Website***

Subject to these Terms and Conditions of Use, the Royal Australian Mint (**the Mint**) grants you a limited licence to access the Mint Dealer Website for legitimate business purposes relating to your Mint Dealer status and/or your purchase or advertising of Mint products.

Except for the purposes stated above, you may not reproduce or download any part of the Mint Dealer Website or material contained on the Mint Dealer Website without the express written consent of the Mint.

This licence specifically excludes any collection or use of any product listings, descriptions, or prices, any derivative use of the Mint Dealer Website or its contents, any downloading or copying of account information for the benefit of another merchant, or any use of data mining, robots, or similar data gathering and extraction tools.

You may not frame or utilise framing techniques in relation to any part of the Mint Dealer Website including any proprietary information (such as images, text, logos, page layout, or form) of the Mint or the Mint's licensors without the Mint's express written consent. You may not use any meta tags or any other "hidden text" utilising the Mint's name or trademarks without the express written consent of the Mint.

The Mint reserves the right to remove or edit such content or immediately terminate access to the Mint Dealer Website in such circumstances.

***Publication of material***

The Mint may in its sole discretion, publish Mint Dealer and product related material via the Mint Dealer website. In particular, this material may include without limitation:

6. Approval to reproduce, publish or otherwise use material issued by the Mint is strictly limited to the approved application for reproduction, publication or use and is not transferable to any third party or other Mint Dealer promotion.

***Ordering Products***

 No other party may order Mint products using the Mint Dealer Website.

***Product Descriptions***

The Mint attempts to describe its product items as accurately as possible. However, the Mint does not warrant that any of its product descriptions or any other content of the Mint Dealer Website is accurate, complete, reliable, current, or error-free.

### ***Pricing***

Except where noted otherwise, the Recommended Retail Price (RRP) displayed for products on the Mint Dealer Website represents the full retail price listed on the product itself. The RRP is a comparative price estimate and may or may not represent the prevailing price in every area on any particular day. For certain items that are offered as a set, the RRP may represent "open-stock" prices, which means the aggregate of the Mint's estimated or suggested retail price for each of the items included in the set.

The Mint cannot confirm the price of an item until it has been ordered. However, the Mint will not charge a Mint Dealer's account until after the order has entered the shipping process.

### ***Electronic Communications***

You acknowledge that by being issued with a user name and password to access the Mint Dealer website you consent to receive any official notices from the Mint electronically via the Mint Dealer Website.

You agree that all electronic notifications issued to you by the Mint satisfy any legal requirement to notify you of any matter.

### ***User Name and Password***

You are responsible for maintaining the confidentiality of your user name, password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your user name or password.

You must take all reasonable action to prevent unauthorised use of the Mint Dealer Website and to report any such unauthorised use to the Mint immediately it is detected.

The Mint may in its sole discretion terminate access, refuse service, remove or edit content, or cancel orders where it detects misuse of the Mint Dealer Website or has reason to suspect breach of these Terms and Conditions of Use and in such event the Mint reserves all other rights it may have in respect of such misuse or breach.
